

Term & Conditions of Enrolment at Lir G.C.

- ❖ Parents are requested to give more than one choice of day and time as places are very limited.
- ❖ Submitting a completed Application Form does not constitute an offer of a place or obligation to accept a place when offered.
- ❖ Places can only be reserved with receipt of a completed application form, registration fee or full fee.
- ❖ Once a place has been confirmed and accepted by you, the full fee is due to secure your child's place
- ❖ Registration payments are non-refundable. However, if the class for which you have registered does not run, your remittance will be returned immediately.
- ❖ Payment will be made via our LoveAdmin platform, is requested two weeks before class begins
- ❖ The Club reserves the right to make changes to class timetables and Coaches
- ❖ Classes run subject to minimum enrollment
- ❖ An annual re-registration fee of €50.00 is due by 14th May of each year to secure your child's place for the next Club Season. Failure to comply with this by the closing date may result in the athlete losing their Club place. The registration fee is non-refundable
- ❖ All fees are payable at the commencement of each term. Failure to comply with this may result in suspension of Club Membership until Club Fees have been settled
- ❖ Entry Fees for competitions, Festivals Display etc.. are to be paid via the Club two weeks prior to participating, in the event of being unable to attend notice must be provided two weeks in advance, failure to do so will incur the entry fee charge, this is general competition rules
- ❖ Club Programs will be compulsory for all members
- ❖ Failure to attend a class by an athlete regrettably cannot be made up or credited
- ❖ If The Club is unable to provide scheduled classes due to unavoidable circumstances, these classes will be given later by extending the Club Calendar
- ❖ All classes take place subject to minimum numbers.
- ❖ Where the minimum number is not reached, the Club reserves the right to run/cancel the class

- ❖ It would be appreciated if parents could ensure that their child attends regularly and on time for class as this is of the utmost importance for your child's enjoyment and success.
- ❖ It is expected that parents/guardians will collect their children at the appointed time
- ❖ There is no provision for supervision of athletes either before or after their lesson time.
- ❖ Should you wish to discuss your child's progress or indeed any other relevant issue with your child's Coach, this should be requested and arranged outside of class time
- ❖ Club Tracksuit and Club Competition Uniforms are compulsory for all competition athletes
- ❖ Athletes are expected to behave in an appropriate manner while on the premises Respect for fellow athletes, teachers, equipment, resources and facilities are imperative.
- ❖ We would ask parents to be courteous and polite to Coaches at all times. Parents who do not comply may be asked to remove their child from the Club..
- ❖ All parents' contact details are automatically placed in our LoveAdmin Account, parents/Guardian's shall be contact through this platform and via the Club gmail account and by phone
- ❖ If a parent decides to remove their child from classes for personal reasons, we regret that fees cannot be refunded
- ❖ If the athlete is leaving after a Term that has already begun, half of the semester fee is payable to the Club
